

2017-2018 Important Dates for Returning Residents

March 20, 2017 (Noon) - Deadline to Submit Application and \$200 Nonrefundable Application Fee for Lottery: 2016-2017 Room and Board Fees Must be Paid in Full. Application and \$200 nonrefundable application must be completed by NOON on March 20, 2017 to be included in the returner lottery process. Applications received after noon on March 20 will be added to the wait list. Resident must have paid all current room and board charges on their account by March 20 in order to participate in the returner lottery process. Please check your myHumboldt account to see if you have any charges currently due.

March 21, 2017 – Theme Housing Survey Due: Anyone interested in living in Gender Inclusive, Native American Living, Rainbow Community, Sankofa House or Students for Consent Culture will need to complete a brief supplemental application and get approval to live in the area.

March 24, 2017 – Lottery Number or Wait List Number Notification: Lottery times or wait list notifications are sent out via email and appear in the Lottery Timeslot section of the myHousing application.

March 30 -April 6, 2017 – New Room Selection Online for 600 Returners: Returning residents participating in the lottery will have the opportunity to select a room online on March 30. Online room selection will remain open until April 6. You will be able to see your 2017-2018 assignment to the selected room in your myHousing account immediately.

May 12, 2017 – Last Day to Cancel From Wait List Without Any Penalty: If you returned your application by noon on March 20 but were placed on the wait list instead of getting a lottery number, you can cancel by May 12 and your \$200 nonrefundable fee will be refunded in full. If, at any time Housing staff offer you a room on or before May 12 and you then cancel, the standard cancellation policy will apply. If you choose to remain on the wait list after May 12, the standard cancellation policy applies.

Late May 2017 – Notification of Room Assignment: Room assignments and other information are emailed to students whose completed application and \$200 nonrefundable application fee were received by noon on March 20, 2017 and participated in the room selection.

June - August 2017 – Wait List Notification: Residents who return their applications after noon on March 20 or receive lottery numbers greater than 600 will be placed on a wait list to be assigned rooms as space becomes available. If we have a wait list, priority will be given to new students before we begin to place returning students on the wait list into rooms.

July 15, 2017 – Last Day to Cancel Housing & Residence Life and Dining Application: Students wishing to cancel their request to live on campus must notify the Housing Office in writing, by fax or by e-mail of this decision by July 15, 2017. Notifying any other university office does not satisfy your obligation to notify the Housing Office in writing. Such requests which are postmarked or received by July 15 will be honored and will forfeit the \$200 nonrefundable application fee. Requests postmarked or received between July 16, 2017 and August 14, 2017, will be honored; however, these requests are subject to forfeit the \$200 nonrefundable application fee along with a prorated daily penalty fee for each day of notice which is less than the required 30 days. Beginning August 15, 2017, cancellations are no longer valid and students will be held financially responsible for the entire academic year room and board fees, per the license agreement. The only time the fees are waived is if we are unable to offer or guarantee you a space by August 15, 2017 and you then cancel your request to live on-campus. **If you remain on the wait list after August 15 and we offer or guarantee you a room and you decline it, you will be charged the academic year room and board fees.**
